FREQUENTLY ASKED QUESTIONS

What is our definition of ownership?

Ownership is Svensk Travsport's term for the person or persons who are registered as the owner of a horse. The ownership may consist of one or more natural and/or legal persons and one of these must act as an authorized representative (see below) for the ownership. Every ownership is unique. If there is any change in who is to be part of an ownership for a horse, or who is to represent the ownership, the new constellation of owners is always considered a new ownership which must be registered with Svensk Travsport.

If it becomes known that an individual named in the application is not the correct owner of the horse, or has incorrectly been registered as the owner of a horse, the Swedish Trotting Association may register the horse as "owner unknown" until the correct circumstances are investigated.

What does it mean to act as an owner representative?

The natural or legal person who has been registered as a representative of an ownership has the authority to represent the ownership in all matters* regarding the horse towards Svensk Travsport and organizations affiliated to Svensk Travsport.

*Also applies to the notification for registering a new owner in the event of a future sale/transfer of the horse.

When a legal person (company) has been registered as owner representative, the authorized signatory/signatories must sign all documents regarding the horse.

When should you register a VAT registration number with Svensk Travsport?

If you report VAT on your horse ownership, you need to notify Svensk Travsport of your VAT registration number. For any payee with a VAT number registered with Svensk Travsport, VAT will be calculated and included in the payment.

What does "Date of transfer" mean and why can't it be changed on the form?

"Date of transfer" is the date when the horse changes ownership and also the date registered with Svensk Travsport for a completed change of ownership. The transfer date must never be changed on the form (e.g. by crossing out or by the use of Tipp-Ex correction), as it is a date that both the "Representative for new Owner" and "Representative for Seller" must agree on and there must be no risk that the date has changed between the signatures of the respective parties.

How to fill in the "Change of ownership" when adding or removing an owner?

The basic principle is that the form must be filled in the way you want Svensk Travsport to register the ownership.

Example 1:

Person A, Person B and Person C are registered with Svensk Travsport as owners of a horse. Person A is registered as authorized owner representative of the ownership. Now, Person B will withdraw from the ownership. Person A signs as "Seller's Representative" as he represents the old ownership. Person A also signs as "Representative of new owner" and Person C signs as "Co-owner". Together, Person A and Person C now form a new ownership.

Example 2:

Company X and Person A are registered with Svensk Travsport as owners of a horse. Company X is registered as authorized owner representative of the ownership. Now, Person B has bought a share in the horse and must now be registered as a co-owner. The signatoryY for Company X sign(s) as "Seller's Representative" as Company X is the registered owner representative of the old ownership. The signatory/signatories for Company X also sign(s) as "Representative of new owner" while Person A and Person B sign as "Co-owners". Together, Company X, Person A and Person B now form a new ownership.

How do you fill in the change of ownership when the owner representative and a co-owner shall switch roles (the owner representative becomes co-owner and the co-owner becomes owner representative)?

Example:

Person A and Person B are registered with Svensk Travsport as owners of a horse. Person A is registered as authorized owner representative while Person B is registered as co-owner. Now Person B must be registered as authorized owner representative and Person A as co-owner. Person A signs as "Seller's Representative" as Person A

represents the old ownership. Person B signs as "Representative of new owner" and Person A signs as "Co-owner". Together, Person B and Person A now form a new ownership.

How do you fill in the form if you have a company under formation?

For a brand, new company, one of the owners fills in the form as "Representative of new owner" and attaches a note that the company is under formation. If you have taken over an existing company, you fill in and sign as "Representative of new owner" and attach a copy of the company registration certificate and a general power of attorney.

How do you register a minor as co-owner?

If a minor is to be registered as co-owner, both guardians must sign the change of ownership on behalf of the minor. If one guardian is the sole custodian, this must be verified by an official document from the appropriate authority (in Sweden Skatteverket).

If a legal entity (company) is to be registered as an authorized owner representative or co-owner, do all company shareholders have to provide their respective information and sign?

It is sufficient for the person or persons who are signatory/signatories for the legal entity (company) to sign the change of ownership.

How do you register a horse lease agreement?

To register a horse lease agreement, use the form "Anmälan om leasing – leasingavtal". Only leasing for racing purposes will be registered with Svensk Travsport.
