

INFORMATION ON OVERNIGHT DETENTION BARN

Welcome as a participant in Elitloppet on the 28-29/5-2022 at Solvalla. A participant requiring a stall in the detention barn on the track on <u>the night before the day of the race.</u>

Detention barns are part of Svensk Travsport's anti-doping activities. The rules applicable to the detention barn are contained in Svensk Travsport's Anti-Doping Regulation Section 5, and subject to this regulation are the physical and legal persons specified in Section 1 of the Svensk Travsport Competition Regulations.

Svensk Travsport monitors the horses but <u>does not assume responsibility as a horse handler</u> in the detention barn. It is therefore important that you, as responsible horse handlers, feel that you can exercise supervision according to your needs. If there is a need for dialogue about this, contact can be made according to the contact details on the next page.

The horse should be in position in the detention barn between 20:00-22:00 on the 28th of May. If the horse is not in place at the latest at the specified time, Svensk Travsport may decide that it should be withdrawn from the race, see information on this in Anti-Doping Regulations Section 5 C. It is the trainer's responsibility to ensure that the horse is in place on time.

If the horse is deemed late to the detention barn due to unforeseen non-rectifiable circumstances, the horse's trainer shall, as soon as possible, make contact according to the contact details on the next page and notify the late arrival. Information supporting the claim of unforeseen non-rectifiable circumstances to the delay shall be presented.

Please note that access to the detention barn will be strictly limited. Only the trainer, horse attendant, driver and a representative of the horse owner will have access to the detention barn. Names of horse attendants, trainers and drivers are taken from the current program for the competition. If there is a need for additional personnel not named in the program concerned, such as farriers or the like, this shall be reconciled and approved by Svensk Travsport before the day of the race.

The area around the detention barn will be controlled by security personnel and there is only one entry and exit point. Checks are carried out on entry to the detention barn to secure access to only authorised persons and to prevent the introduction of unauthorised preparations or unauthorised equipment. The checks may also consist of a search of persons clothing, materials or equipment for those who have access to the detention barn, in accordance with Section 5 of the Anti-Doping Regulation (E). Any search is carried out in which case by specially designated personnel and gender is taken into account.

In the detention barn, all contacts with your horse will be overseen by security personnel. All activity in the detention barn will also be monitored with surveillance cameras with video recording.



Representatives of Svensk Travsport open the doors of the detention barn in the morning between 06.00-06.30 for feeding the horses.

For races with qualification heats and finals on the same day, all horses participating in qualifying races are subject to the detention barn regulations until a definitive race result is determined. Those horses that have not advanced to the final will then be released from the regulations while the horses who are to participate in the final shall immediately return to the detention barn and remain subject to the regulations until a definitive final result has been determined.

In the event of only one race, horses are subject to the regulations until a definitive race result is established. Also note that Svensk Travsport's rules for doping sampling always apply and that horses stalled in the detention barn are likely to be sampled.

It is the responsibility of the trainer to provide this information to the horse attendant and the owner's representative who has access to the detention barn.
